It also looks like the symbols for the major highways didn't render properly when the PDF file was generated. In their current forms, they're unusable and can't be used to understand the data in the various tables because you can't relate the data in the tables, which is by district number, to the districts that have no labels. I spotted these issues with a cursory review of the report. There are probably other issues like this as well. Hopefully this will all be corrected when the final version is proofread and checked for quality issues.
