To ensure equal representation, we suggest that the Commission take the prison populations in to account and use allowable deviations and try to minimize the impact of the Census Bureau's prison miscount. In fact, this year, the Census Bureau published data, the P5 table, for the express purpose of making it easier for jurisdictions to adjust for correctional populations. We have also compiled a list of each state facility in Arizona, the corresponding census block number, and the incarcerated population counted there by the Census Bureau. I am confused that the IRC seeks public comments on its grid maps, which do not play a substantive role in the overall effort to draw new districts. I hope that this scheduling of hearings will ramp up vigorously and with better notice when the IRC publishes its draft maps. My concern with the hearing schedule is threefold. First, it appears that very few - perhaps only three - of the 14 sites are located in communities of color. Given the data from the Census showing a significant growth in Arizona's minority population, that seems to be an inadequate allocation of the opportunity to be heard. Additionally, the satellite locations at Window Rock and Kayenta are restricted to 25 persons. I understand that the Navajo Nation has a 25-person limit in place for gatherings as part of its covid plan. I am not sure that I understand why there is a limit for the township of Kayenta. Perhaps it has instituted a gathering due to its proximity to the Nation. But these limits, coupled with the limited number of hearings in minority-populated parts of the State, suggest, fairly or not, that the IRC is being cavalier about its obligation to hear minority voices. Finally, the IRC has scheduled these 5 hearings to last only one hour - from 4 to 5. For each of the 5 main hearing locations, there are 1 to 4 satellite locations. The 1 hour time limit along with the fact that folks from multiple sites will compete for that limited time makes the chances of hearing a broad spectrum of opinions unlikely, particularly from minority voices.

I'm a retired software developer in Yuma, 85365, CD4 and LD13. Chair Neuberg and Commissioners, thank you for the opportunity to share my views with the Commission tonight regarding the Grid Map that was generated as the starting point for drawing the Draft Maps and eventually the Final Maps for Congressional and Legislative District boundaries. According to the Arizona Constitution, the process to arrive at these maps is expected to be transparent, carried out in public so we can feel confident it's as free of political bias and tampering as possible. I have several concerns about this process already that I feel are important to raise and give voice to. First, it's not clear that the mapping consultants actually carried out the wishes of the Commissioners when they produced the original Grid Map. The instructions agreed on by the Commissioners stated that the starting point would be the "Township Median" of the state, and rotate clockwise, gathering voters in neighboring census blocks until the target number for a district was reached. However, the commission omitted the other important instruction, namely which direction from census block containing the township median should be the next one. Should it be the one directly above it? Or to the right? Or perhaps below it? The question is really which block is clockwise from the one in the center? That choice would have affected the boundaries of the resulting Grid Map in subtle ways. But because the Commission failed to specify it, that choice was left to the mapping consultants, who had to act on an assumption in order to generate the map on time. We also don't know how neighboring blocks were combined to grow each district, but they appear to have been added radiating from the starting point. The published diagram on the website doesn't tell us much. In any case, the choices they made have never been shared with the public
