As an Independent commission, you have the charge to remain independent from political manipulation to guarantee that our voting districts are fairly drawn. Gathering input for the range of citizens in the state is a critical part of that process. However, we have seen, especially in recent years, some people have come to public meetings with the sole purpose of disrupting the process. Some political operatives have even paid stooges to appear at events like these to present misinformation about the legislative districts. We hope that the IRC will do a couple of common sense things to prevent disruptive and fraudulent presentations. First, we suggest that you post a list of civil presentation practices that include speaking quietly and respectfully when providing testimony - and refraining from unruly behavior during the presentations of others. I went back and listened to their interview and caught that they have agreed to stop consulting for political parties. This indicates they recognize the potential for conflicts of interest – real or perceived. The remainder of their answer was essentially – “trust us – we’ve got this covered.” They named an internal ethics and compliance process for Snell and Wilmer. Again this recognizes the prospect of real and perceived conflicts of interest, but does not address the concern of the public for impartiality or transparency. The firm’s process is in place to protect the firm – not the IRC or the public. Neither the IRC, nor the public, should be asked to accept at face value the internal processes of the firm. The IRC and the public deserve more.</p> <p>I ask that you either 1) request the firm suspend its political consulting for the duration of their contract with the IRC or 2) establish PUBLIC policies, procedures and protocols for standardized and regular disclosures of the work Snell and Wilmer is conducting that intersects with the interests of redistricting.</p> <p>As an example, the Snell and Wilmer website states the individual lawyer: regularly advises candidates, consultants, lobbyists, political action committees (PACs), ballot measure and independent expenditure committees, political parties, municipalities, corporations, election-related vendors, trade associations and other tax-exempt organizations, and individual donors and political contributors.</p> <p>I emphasize five specific categories – candidates, consultants, municipalities, individual donors and political contributors. These entities are primary stakeholders – where you draw the lines directly impacts their individual political futures and fortunes.</p> <p>To draw this out further: I don’t know which municipalities Snell and Wilmer represent – but suppose they represent Glendale where I live, 2010 population of 191,719. Despite having a population that would easily be contained in just one state legislative district, Glendale is currently divided among seven state legislative districts 13, 15, 20, 21, 22, 29, and 30. If Snell and Wilmer is now representing Glendale, will our city be more fairly treated in 2021? If they are not representing Glendale, will we be sliced and diced again?</p> <p>This question highlights just one example of the direct intersection between the political work of Snell and Wilmer and the redistricting work of the IRC.</p> <p>This creates a substantial threat to the IRC as it quite easily draws into question the integrity of the core of your work – drawing districts for fair and equal representation for all Arizonans. So many IRC actions taken “in an abundance of caution” to establish public trust and diminish risk for litigation seem performative in comparison. (Such as not posting meeting transcripts that may not exactly match the video – even with a disclaimer.) By taking one of the two actions noted above, this very real and serious threat to the ideals, integrity, and transparency could be mitigated.</p> <p>This report by the Pew Research Center (<a href="https://www.pewresearch.org/politics/2021/05/17/public-trust-in-government-1958-2021/">https://www.pewresearch.org/politics/2021/05/17/public-trust-in-government-1958-2021/</a>) reflects the low level of public trust in American government and institutions. Is there a reason you are not asking the Census Bureau itself to provide us with a defense of their use of Differential Privacy from a legal perspective in addition to the pro/con analyses from your legal scholars? It seems their view of this issue would be helpful to take into consideration as well.  Also, does it matter what the legal analysis comes up with? In the end isn't the commissioner's primary concern how to understand and interpret the meaning of the data that it does receive? You just need to know how the introduction of differential data affects the level of accuracy that can be reasonably expected of the maps you draw. Since the apportionment data and basic data used in redistricting will not be adjusted for differential privacy, this is not something that should be of primary concern. It only comes into play when you fine-tune the district lines on your maps to deal with demographic, housing, and employment related data (which is adjusted under differential privacy). 06/22/2021 - 12:12	06/22/2021 - 12:12	06/22/2021 - 12:12	Barbara Burstein		<p>Dear Commissioners:</p> <p>I am writing because I am concerned about the public hearings that the Independent Redistricting Commission will be holding, and what measures the Commission will take to ensure the the hearings are conducted in an orderly fashion and safely.</p> <p>One vital step for safety is prohibiting firearms and other weapons from the public hearings</p> <p>Further, as Commissioner Lerner expressed, I share concerns about the recent takeovers of local school board meetings around the State. While the public should have the opportunity to communicate with the Commission, the hearings should not be overtaken by political extremists, and those whose goals are the taking control of or shutting down the public hearing. Instead, the the public should be able to participate, as long as it is with respect, established norms, and a decorum of civility.</p> <p>Before the meeting it would be beneficial to adopt and follow commission rules of procedure, including Robert's Rules of Order. Where ground rules are understood going in, it can certainly aid in maintaining order and civility. Consider the option of remote meeting attendance for individuals who cannot attend the meeting in person. Also, for those who may not be comfortable commenting at the meeting in person, by allowing comments by email or handwritten letters that can be made part of the record. Further, utilizing a sign-up sheet for those who wish to address the Commission that includes the person's name, address, phone number would help understand who and how many intend to speak, and may facilitate determining the order in which speakers will be called.</p> <p>Determining ground rules for how the meeting will be run and letting the public know those in advance may also assist the meeting to be orderly. These would include having a reasonable time limit for comments, for example, 3 to 5 minutes, and enforcing that consistently. Also, stating the values and behavior that the public will be expected to demonstrate during the hearing, such as treating others and their opinions respectfully, refraining from personal attacks, not interrupting, and other norms of decorum.</p> <p>Also, it would be beneficial to put the public on notice before the hearing, for example, in the notice of hearing or the agenda. For example, informing the public in advance that the Chair reserves the right to ensure that all comments are appropriate and abide by rules of civility, which applies to the audience as well as to the speakers. Individuals who refuse to abide by these ground rules may not be permitted to continue speaking. Certain individuals who are disruptive and uncivil should not be allowed to intimidate or silence Arizonans who want to make their voices heard at the public hearings.</p> <p>I urge the Commissioners to consider adopting these measures to aid in conducting safe and orderly public hearings.</p>

The AZ Republican state leadership has continued this process of disinformation by its insistence on an "audit" of votes in Maricopa County although the election results have already been confirmed and certified. Add to this the potential for gerrymandering and the proliferation of do-it-yourself online redistricting tools, and its plain that the IRC faces a daunting problem to maintain the integrity and transparency of its process. Use of political disinformation, including bad mapping from political operatives would undermine the entire redistricting process.</p> <p data-bbox="1167 620 1955 1013">It does not appear to me from the IRC website that anyone other than the IRC can use the IRC mapping tool to draw maps; anyone else would use one of the do-it-yourself tools. The Commission must give consideration to and outline means to protect the process by, at a minimum, requiring accurate and complete identification of any organization that posts maps, including disclosure of any political affiliation, and banning of fake accounts. Any map posted should disclose the software used to draw the map. For any such software used, the code or algorithms used to score districts must be disclosed, users must have the ability to obtain data and redistricting plans in machine-analyzable format, and any organizations providing financial backing must be disclosed. Again, the IRC should ban fake accounts and require identification of organizations that post comments. It should also develop its own methods for fact checking and rules under which false statements by political operatives can be removed or at least identified as false statements from a political operative. Links to fact-checking sites should be included for use by the public. Disinformation regarding threats to safety at public hearing sites must be promptly removed and reported to the proper authorities.</p> <p data-bbox="1167 1276 1955 1481">Because disinformation from any person or organization can be harmful, it is important that Arizona voters who access the online mapping tool have information on how to recognize disinformation—such as excessive typographical errors, over use of capitalization, punctuation that includes many exclamation marks, an over-the-top message, and lack of identified reliable sources for the information—and to be reminded not to cause the further spread of disinformation by sharing it. There should be a way for users to report disinformation to the platform.</p>
