As a resident of Coconino County, I'm happy to see us on the list. But I do wonder about the practicality of choosing "remote" rural counties like Coconino and Navajo for your first sessions. Given the immense geographic size and dispersion of population, you aren't leaving much time for getting publicity out (eg some communities have only weekly newspapers) or for people to be able to get childcare or time off work arranged (eg for people who work at Grand Canyon or in Page). And do you have Navajo or Hopi translators already arranged? Do you have a background presentation already put together that addresses the issues these rural (and diverse) communities will benefit from? Given that you are planning two sessions in Maricopa County - I would respectfully suggest that maybe you have one of those sessions be your initial effort, so you are able to prepare and test many of the aspects of your session (background presentation, rules for submitting comment, signing or other ADA services, security, etc.) without the added complications of travel and remote community locations. Secondly - I observe you plan your virtual townhalls to take place during these meetings. That seems very problematic for the working public! Very hard for most normal people to take time off work on Tuesday mornings to call in for such a session. I strongly urge you to schedule at least a couple of such sessions in the evenings so that hard-working citizens of Arizona have a chance to be heard.
