I believe the economic codependence of industries within supply-chains has important implications for the redistricting process in Arizona. Because the industries in I-10 industrial corridor of Pinal County rely on the raw materials supplied by the rim country and copper corridor, they are part of the same economic community of interest and should be part of the same congressional district. The I-10 Industrial corridor (also known as the Arizona Innovation and Technology Corridor) is defined as the region in between Phoenix and Tucson according to the Pinal County Department of Economic Development. It includes cities such as Florence (home of Florence Cooper), Coolidge (home of the Nikola Motors manufacturing plant), Casa Grande (home of the Lucid Motors manufacturing plant), Eloy, the Avra Valley (home of the Silver Bell Copper mine), and Marana (home of the Rillito Cement Plant). This corridor has become bedrock to a number of important industries. For instance, EV manufacturing and supply-chains have become central to this corridor over the last decade. According to AzBigMedia 5/13/2021, "Pinal County finds itself at the epicenter of an EV cluster that is expected to rapidly change the landscape of this otherwise quiet low-desert region." Lucid motors recently completed a 500-acre, \$700 million EV manufacturing facility which will employ approximately 2,000 workers. Nikola is also completing a facility to build battery-electric and hydrogen-electric rucks. This manufacturing plant is also expected to employ up to 2000 workers.
